# Procedure 20335r: Rates for Lodging and M&IE

### A. Domestic Lodging and M&IE Rates (CONUS)

The University uses the Federal CONUS lodging and meals & incidental expenses (M&IE) rates. If neither the city nor the county is listed, the location is a standard destination with a rate of \$107 for lodging and \$59 for M&IE.

Notes:

- Lodging Rate excludes local taxes and surcharges.
- M&IE Rate includes tips, taxes, personal telephone calls, laundry, and transportation to where meals are taken.
- To check allowable hotel rates by location, preferably by zip code, please use the <u>gsa.gov</u> web site.

#### A.1 Meals and Incidental Expense (M&IE) Breakdown:

The following table shows the breakdown of continental breakfast/breakfast, lunch, and dinner components of the maximum daily reimbursement (per diem) rates for meals and incidental expenses while on travel. Refer to **Section 301-11.18 of the Federal Travel Regulation** for guidance on deducting these amounts from your per diem reimbursement claims for meals furnished to you by the government.
